The goal of the Future Ready Schools – New Jersey (FRS-NJ) Certification Program is to support the statewide modernization of New Jersey schools, promoting a systemic approach to change through the cycle of transformation where districts envision, plan, implement, and assess continually with student learning as the focal point for their aligned efforts. Participation does not obligate the schools and district to any specific time commitment or budgetary obligations. Schools and districts may choose to cease program participation at any time.
